

IMPORT AGREEMENT

Kleine Münsterländer – Group North America (KIM-GNA)

Importing a puppy is a special privilege which brings with it both rewards and responsibilities. A KIM-GNA member wishing to import a puppy or adult KIM is asked to comply with the following agreement. KIM-GNA engages in significant work to import, or to assist in the import, of a puppy to North America. There also is a limited supply of puppies available for import. The reason that KIM-GNA goes to this effort, both in importing the puppy and requiring this agreement, is to ensure the genetic health, performance, and adherence to the FCI standard for the KIM within Group North America. Your cooperation with this program makes an important contribution to the overall success of KIM-GNA, as we aim to breed high quality hunting dogs for our members and future members. By working with and through the Breed Warden of KIM-GNA, research will be done in conjunction with members of the Breeding Commission of KIM-D to try to ensure a puppy which will potentially broaden, diversify, and strengthen the breeding base of the dogs in GNA and be an excellent hunting companion and family member for the buyer.

The following outlines the responsibilities of the KIM import buyer:

- 1. The prospective importer must be a member in good standing of KIM-Group North America.
- 2. The dog imported is for the ownership of the prospective importer and not intended for transfer to third party ownership.
- 3. In consideration of KIM-GNA's assistance with the importing of this puppy, the KIM-import buyer agrees to:
 - a. Test the dog in the breeding tests of the JGHV (German Versatile Hunting Dog Association) the VJP (Youth Test) and the HZP (Fall Breed Test)
 - b. Complete a Hip Dysplasia test according to club guidlines, and
 - c. Present the dog in a KIM-GNA Breed Show after 15 months of age.
- 4. The KIM import owner may petition the Breed Warden of GNA for an exception to #3 if the dog is determined to have an eliminating fault preventing it from qualification to breed.

- 5. The import buyer also agrees to breed a female at least once and have a male at stud for three years after fulfilling all requirements for breeding approval. After three years, KIM-GNA would have the option of collecting semen from the stud dog, prior to neutering. If the semen were used later in breeding, the owner would receive the stud fee.
- 6. Finally, the import buyer also agrees to the following transfer of ownership provisions:
 - a. The imported dog is eligible for transfer of ownership to another KIM-GNA member in good standing at any time. The new owner must assume all responsibilities and restrictions of the Import Agreement and enter into a separate Import Agreement directly with KIM-GNA.
 - b. The KIM must be altered (neutered or spayed) regardless of age before the transfer of ownership to a non-KIM-GNA member or if the owner is no longer a member of GNA.
 - c. You agree that if you do not follow provisions 5, 6(A) or 6(B), that would result in harm to KIM-GNA that would be substantial, although difficult to measure in money damages, and that money damages would not fully remedy or address the harm to KIM-GNA. Accordingly, you agree that KIM-GNA may be entitled, among other things, to an equitable order from a court that would force you to comply with provisions 5, 6(A) or 6(B), including, for example, requiring you to spay/neuter the imported dog/bitch.
